Every participant disability must be classified by medical doctor

All competitors must have Medical Release signed by official national doctor.

All National Federation participants must be WFF Member for 2017.

All athletes who want to enter the World Championships competitions MUST have a Fudokan BUDOPASS with the Annual Visa – 2017.

#### 1. CHILDREN

CHILDREN I. AGE 6-7 YEARS (BORN IN and younger2010) CHILDREN II. AGE 8-9 YEARS (BORN IN 2008-2009) CHILDREN III. AGE 10-11 YEARS (BORN IN 2006-2007) CHILDREN IV. AGE 12-13 YEARS (BORN IN 2004-2005)

## 2. YOUTH

CADETS AGE 14-15 YEARS (BORN IN 2002 – 2003) JUNIORS AGE16-18YEARS(BORN IN1999 – 2000-2001)

#### 3. SENIORS

YOUTHS AGE 19-21YEARS (BORN IN1996-1997-1998) SENIORS, YOUNGER GROUP 21-34(1995-1982) SENIORS, OLDER GROUP (FROM 35 – 49 YEARS) VETERANS

# **B. COMPETITION CATEGORIES**

#### 1. Individual Kata

Boys/Men / Girls/Female only people with disabilities

#### 2. Kata Team

Boys/Men / Girls/Female minimum one or maximum two people with disabilities per team

for all age categories.

# 3. Individual Kihon


Boys / Girls only people with disabilities for children categories only.

# **C. DISABILITY CATEGORIES**

An official WFF classificator or doctor may reclassify athletes at any time during the competition. All athlets are asked to bring an official document of disability with them.

There are 4 classification categories of disabilities for the competition:

- Wheelchair User
- Blind and Visually Impaired
- People with Learning and Mental disabilities e.g. autism
- People with other disabilities









# **COMPETITION DETAILS**

# CHILDREN INDIVIDUAL KATA: only athlets with disabilities

Children A, B, C, D: eliminations, semi-finals, finals - FLAG SYSTEM no Repassage TYPE OF KATA (individual and team):

Group A: elimination/ semi-final/ final Heian 1-2-3, Taikyoku

Group B: elimination/ semi-final/ final Heian 1-2-3-4-5, Heian Oi Kumi

Group C: elimination/ semi-final/ final Heian 1-2-3-4-5, Heian Oi Kumi, Bassai- Dai

Group D: elimination/ semi-final/ final Heian 1-2-3-4-5, Heian Oi-Kumi, Bassai- Dai,

Kanku Dai, Jion, Enpi

For all other age categories the kata (from Shotokan or Fudokan) is free.

Wheelchair kata is completly free.

# **TEAM KATA:**

Each team will be composed of 3 contestants (1 athlete can be from another group, older, younger, sex, ...)

Mixed teams are allowed, (e.g. two girls plus one boy starts at girl competition, two boys plus one girl ...)

Each team must have minimum one and maximum two people with disabilities (inclusion aspect).

No Application of kata (bunkai) necessarry.

For all categories the kata is free.

#### **KIHON KUMITE:**

Program like official WFF Kihon Kumite program. Only for athlets with disabilities

# Competition Rules FOR PEOPLE WITH DISABILITY

# **Article 1: Official Clothing**

Competitors and their responsible persons must wear an official uniform.

# **Article 2: Competition Field**

- 1. The competition field must be suitable for people with disability and equipped in such a way that dangers are excluded.
- 2. The competition field must have a sufficient size, allowing to perform the forms without any problems.
- 3. To ensure a smooth presentation of the forms a stable, plain surface is required. Usually mats for tournament are suitable.

# **Article 3: The Organization of Kata Competition**

- 1. The choice of a Kata is free.
- 2. It is up to the organizer, to merge groups because of low participation. The competitors or responsible persons are expected to be part of the decision, which is to be made in the interest of the athlets.
- 3. The single competitions consist of single presentations, which are separated according to gender.
- 4. It has to be distinguished between standing and seated groups. Furthermore it has to be distinguished according to the degree of disability (from 50% to including 70% and from 80% to 100%).
- 5. It is possible, not to differentiate the degree of disability within the groups. The Kata presentations will than evaluated with point system. At the end the participants with the lowest degree of disability (from 50% to 70% including) will get one point subtracted from their total evaluation. At the end of the match the points are counted and the placement with respect to the subcontracted points are announced.
- 6. In a Grand Champion-Competition the point reduction regulation will also be applied.

#### **Article 4: Jury Committee**

- 1. For each round, the jury (3 or 5 judges) will be appointed from the chief judges or from the ground / mat leader.
- 2. The judges of a kata competition should not be from the same nation, national association, district or club as one of the participants, as far it is possible.
- 3. In addition, administrative persons for the evaluations and announcers / speakers will be introduced.

#### **Article 5: Decision Criteria**

Kata has to be performed with competence. A clear understanding of the traditional principles which are included in the kata must be visible. When evaluating the performance, the judges have to take into account any restrictions by each individual disability and have to pay attention to:

- a) A realistic demonstration of the meaning of the kata
- b) Understanding of the used techniques
- c) Timing, rhythm, speed, balance, charm and strength application
- d) Correct, adequate respiration for the performance of the techniques
- e) Right focusing on the attention and the concentration
- f) Correct positions with right tension in the legs, excluding e.g. wheel chair drivers
- g) Adequate body tension, e.g., in the lower abdomen
- h) Correct performance of the techniques of the demonstrated style
- i) The realization should also be valued in respect to other criteria, such as the degree of difficulty of the shown kata.

# **Article 6: Realization of Competitions**

- 1. The appearance of "disabilities" are so complex, that it seems impossible, to satisfy all kinds of disabled athlets with their individual competition rules. The WFF Ikkaido competition rules are flexible to use. Competition rules for "people with disability" differ primarily from general competition rules by restrictions with the repertoire of forms, because the physical or the mental conditions according to the kind and degree of disability of the individuals are extremely different.
- 2. With reasonable doubt about the restriction due to the disability of the participant, it is up to the organizer and in agreement with the competitor or the responsible person, to withdraw the participant from the starting list. This means that competitors which are able to perform according to general competition rules, don't have to be evaluated according to this set of present rules. Decision should be made in the interest of the athlets.

This form set of rules was created to allow people with disability to measure themselves in competitions in the area of the Martial Arts in terms of Inclusion. The set of rules should be available not only to everybody who is organizing inclusion competitions, but it is appreciated to initiate further competitions for people with disabilities. The only condition is, that prior to the distribution, permission is granted.

# **Article 7: ICD CLASSIFICATION**

The ICD (International Classification of Diseases) is an internationally accepted standard diagnostic tool of the WHO (World Health Organization). The relevant version is ICD-10 (the guideline for this work). Therefore the ICF (International Classification of Functioning) should be used. This could be created by therapists, doctors, or medical expert staff.

#### WHEELCHAIR USER

Grading according to ICD-10:

S 14.: Injury of nerves and spinal cord at neck level S 14.7!: Level of injury

S 24.: Injury of nerves and spinal cord at tharax level S 24.7!:

Level of injury

S 34.: Injury of nerves and lumbar spinal cord at abdomen, lower back and pelvis level S 34.7!:

Level of injury

T 05.: Traumatic amputations involvins multiple body regions T 05.3: Traumatic amputation both feet

T 05.4: Traumatic amputation one foot and other leg T 05.5:

Traumatic amputation both legs

No amputation appliance allowed (possible if there is no money in countries with lower standard)

# **BLIND AND VISUALLY IMPAIRED**

Grading according to ICD-10:

H 53: Visual Disturbances

H 54: Visual Impairment including blindness (binocular or monocular)

- H 54.0 Blindness, binocular (on both eyes)
- H 54.1 Severe visual impairment, binocular
- H 54.2 Moderate visual impairment, binocular
- H 54.4 Blindness, monocular (on one eye)
- H 54.5 Severe visual impairment, monocular
- H 54.6 Moderate visual impairment, monocular

# Category/Grade:

- 1. Moderate visual impairment: Distance visual acuity worse than 6/18 to 6/60
- 2. Severe visual impairment: Distance visual acuity worse than 6/60 to 3/60
- 3. Blindness: Distance visual acuity worse than 3/60 to 1/60
- 4. Blindness: Distance visual acuity worse than 1/60 to light perception
- 5. Blindness: No light perception

#### **LEARNING AND MENTAL DISABILITY**

Grading according to ICD-10:

F 70: 0 Impairment minor (IQ 50-69)

F 71: 0 Morerately Impaired (IQ 35-49)

F 81: 9 Developmental disorder by academic skills

F 82: 0 Developmental disorder by motor function

F 90: 0 Hyperkinetic disordes

Q 90:0 Down Syndrome

#### **Characteristics**

XXX.0: impairment inexisting (without, not,...) 0-4 %

XXX.1: impairment simple distinctive (fragile, remote,...) 5-24 %

XXX.2: impairment moderate distinctive (middle, quite,...) 25- 49 %

XXX.3: impairment grave distinctive (heavy, extreme,...) 50- 95 %

XXX.4: impairment complete distinctive (massive, full,...) 96- 100 %

# **CLASSIFICATION SYSTEM**

Competitors are considered to be eligible for the competition if they are classified according to the ICD (International Classification of Diseases) and ICF (International Classification of Function), the internationally accepted standard diagnostic tool oft he WHO (World Health Organisation). In order to participate, athletes must be accompanied by medical certificates together with disclosure of the official National Federation.

At the event itself an extra testing takes place by experts of the WFF, one national coach has to be with the athlet all the time. Every code covers a manifestation of disability!

Red-Level: Severe level of disability

Yellow-Level: moderate level of disability

Green-level: minor level of disability

blue-level: lowest level of disability

ICD, ICF and extra testing right at the Competition together are tools to more accurate differentiations in each category. To make visible for spectators on start number ( back of the Gi), and on scoreboards
